Over the past eleven days, at least five attacks have been carried out by insurgents on election-related facilities across Afghanistan.

Members of the public have meanwhile said that public confidence in the election process will be further damaged if the government does not outline full security measures.

Educational qualifications and work experience in government and non-governmental organisations have been prioritised over securing a high number of votes.

Mohammad Naeem Ayubzada, head of the Transparent Election Foundation of Afghanistan (TEFA), said: "Unfortunately, there have been no encouraging changes in the new election law."

"Conditions for women should have been simplified so that they are encouraged to participate in elections. Women should have been allowed to win even with limited votes to pave the ground for their active participation in elections. But unfortunately, such conditions don't exist," he said.

"There are no rules for preventing strongmen, warlords, criminals and traitors from contesting the vote. The law says courts can decide crimes against nominees. But no courts have so far been specified for investigating the crimes," Ayubzada explained.

Yousuf Rashid, chief executive of the Free and Fair Election Foundation of Afghanistan (FEFA), said conditions mentioned in the new law for candidates were not enough. The only way people can follow was to vote for qualified candidates and strictly watch the election process, he commented.

Syed Hafizullah Hashimi, an Independent Election Commission (IEC) member, said any complaints about conditions for candidates should be referred to the Wolesi Jirga and the Presidential Palace.

Accepting or rejecting suggestions of election observers and the civil society about the law is the prerogative of parliament and the Presidential Palace. The IEC was obliged to follow the new law, he concluded. (Pajhwok)

The worst voter registration turn-

out was seen in Wardak, with only 458 people registering. Next was Nuristan with only 578.

Election observers and monitoring groups have blasting the election commission for not having rolled out a comprehensive election awareness campaign.

Critics said the IEC's failure to conduct such a campaign, and the absence of a voter registration database, were indicative of poor leadership and mismanagement in the election commission.

But the IEC on Monday said it will finalize the voter registration database within the next two days.

"The commission should have made the database very early so that the data would be directly entered in to the database and would be available to the people on the website," said Yousuf Rashid, chairman of Free and Fair Election Commission Forum of Afghanistan (FEFA).

This also comes just days after the IEC announced the timeline for the country's parliamentary and district council elections which are due to be held in October.

According to the timeline, the voter registration process will end on June 12.

Based on the timeline announced by Sayad, registration of candidates

for both parliamentary and district council elections will begin on May 26 and end on June 12.

A preliminary list of candidates will be announced on June 28 while the final list will be out on August 3.

The candidates can withdraw their nominations between June 29 and August 1.

The campaign for parliamentary elections will begin on September 28 and end on October 17, while that for district council elections will be between October 3 and October 17.

The final results of parliamentary elections will be announced on December 20 while the final results of district council elections will be on January 24.

IEC has meanwhile said that public confidence in the electoral process was badly damaged during the crisis following the 2014 presidential elections and that the commission will do everything possible to rebuild the trust in the process. (Tolo news)

the Pentagon said it remained committed to staying in Afghanistan till the time terrorists were defeated.

"We strongly condemned the deplorable suicide attack on a voter registration center and Kabul that killed approximately 60 people and wounded over 100 others," Col Robert Manning, Pentagon Spokesman told reporters during an off-camera news conference.

"This senseless violence targeting innocent civilians exercising their fundamental democratic rights exposes the savagery and inhumanity of terrorists," he said. The US, along with its Afghan and international partners, were committed to destroying ISIS in Afghanistan, he added.

"We stand with the people and government of Afghanistan and their fight against terrorism. The US reaffirms its support for the Afghan government, Afghan security forces and the independent electoral commission in their efforts to ensure the elections process is transparent, credible and safe," Manning said.

The Trump administration, he said, was still focused on its South Asia strategy -- the ability to regionalise support to defeat terrorists in the region. "It's a tough fight obviously. But we still continue to move forward in accordance with the strategy," Manning said.

The attack on the polling station reaffirmed American commitment to Afghan partners and the reason why it had had to focus on rooting out violent extreme extremism.

"When citizens can't go and register and exercise their democratic right to vote, that's a problem. They certainly deserve it and that's why we're going to stay there to make sure that we can work with our Afghan partners to allow them that right," Manning concluded. (Pajhwok)

Iran Warns Trump It Might Withdraw From Non-Proliferation Treaty

LONDON - A senior Iranian official said on Tuesday that Tehran might quit a treaty designed to stop the spread of nuclear weapons if U.S. President Donald Trump scraps the nuclear accord Iran signed with world powers in 2015.

Trump has said that unless European allies fix what he has called "terrible flaws" in the accord by May 12, he will restore U.S. economic sanctions on Iran, which would be a severe blow to the pact.

The other powers that signed it - Russia, China, Germany, Britain and France - have all said they want to preserve the agreement that curbed Iran's nuclear program in return for the lifting of most international sanctions.

In a news conference broadcast on state television, the secretary of Iran's Supreme National Security Council, Ali Shamkhani, said the Atomic Energy Organization of Iran was ready for some "surprising actions" if the nuclear deal was scrapped.

Answering a question about the possibility of Tehran withdrawing from the Nuclear Non-Proliferation Treaty (NPT), Shamkhani said: "This is one of three options that we are considering."

The objective of the NPT, which took effect in 1970, is to halt the spread of nuclear weapons-making capability, guarantee the right of all members to develop nuclear energy for peaceful ends. The original five nuclear weapons powers — the United States, Russia, Chian, Britain and France - would also phase out their arsenals.

Iran has been a non-nuclear-weapon state party to the NPT since 1970. Iranian President Hassan Rouhani also warned Trump on Tuesday to stay in the nuclear deal or face "severe consequences" (Reuters)

Indonesia Plans to Challenge U.S. Anti-Dumping Duty on Biodiesel to WTO

JAKARTA - The Indonesian government has arranged and prepared a lawsuit to the World Trade Organization (WTO) on U.S. high antidumping tariff against bio-diesel imports from Indonesia, a senior trade official said.

The U.S. International Trade Commission (USITC) added more duties on the already steep anti-dumping tariff and countervailing duty on biodiesel import from Indonesia to between 126.97 to 341.38 percent on April 9, essentially making it almost impossible for the Indonesian biodiesel product to enter the U.S. market, according to the trade ministry. Trade Director for Security of the ministry Pradnyawati Pambagyo said that Indonesian exporter companies have submitted the appeal to the U.S. court and now the Indonesian government and the firms are waiting for the decision of the U.S. court. The ministry will also file a lawsuit to the WTO if the court decision remains seriously harming Indonesia's bio-diesel shipments to the United States, according to the official.

"Basically, the government and the companies are ready to seek justice to the highest level," Pradnyawati was quoted by Kontan media as saying. Export of Indonesia's biodiesel grew 47.31 percent on average from 2014 to 2016, according to the ministry.

"At present, there is no more exports of bio-diesel to the United States," said Pradnyawati. (Xinhua)
